Cuffs are constructed with a 245 g/m² 60% Modacrylic (Protex), 38% Cotton, 2% Antistatic fibre 1 x 1 rib fabric, and collars are constructed with a 240 g/m² 60% Modacrylic (Protex), 38% Cotton, 2% Antistatic fibre 1 x 1 rib fabric. Seams are contructed with a 100% aramid sewing thread. The long johns and T Shirt are available in six sizes, and the neck tube and balaclava are available in a single one size fits all size. The garments are available in Royal Blue, Yellow, Navy and Black.
